CCSOMO's RRH Program seeks to move homeless families as quickly as possible into permanent housing & to achieve stability in housing following a Housing First model which does not set preconditions to entry such as sobriety or minimum income threshold. Focus is to reduce barriers so clients can become stably housed & not easily terminated from services. CCSOMO receives referrals from Coordinated Entry which completes the screening & assessments. CCSOMO case managers provide clients with: housing stability case management; rental & financial assistance; access to supportive services including assistance in attaining mainstream benefits & community resources in order to achieve stability in housing. Program will serve Jasper & Newton counties in CoC (MO-602). The need for RRH Program in this area is great. Based on CCSOMO's experience with SSVF & ESG, not only is there an identified need, but many are waiting for assistance including homeless veterans who do not qualify for SSVF, individuals & families residing in emergency shelters located in this region, those fleeing domestic violence & those who are literally homeless. CCSOMO does outreach to connect with homeless & those at-risk households in order to offer services that can result in stable permanent housing. CCSOMO reaches out to landlords to establish relationships that can lead to lower barriers for clients. Homeless individuals & families served under this program must meet eligibility criteria on entering the program of coming from the streets, emergency shelters, safe havens, institutions or transitional housing & client data is entered into HMIS. Targeted populations are chronically homeless, veterans, families with children, individuals or households with members who have substance abuse, mental illness or other disabilities. CCSOMO case managers work with clients in a holistic & individualized manner using a family strengthening model that empowers clients in the decision making process. This individualized approach allows case managers to work with client to find housing type, scale & location that will fit the needs of client. Case managers follow FMR, Habitability standards & rent reasonableness standards when assisting clients in housing search & evaluating lease agreements. Outcomes measured are: number of households stably housed when rent assistance ceases & at follow-up; number of households that increased household income either through employment or access to mainstream benefits; number of households who become gainfully employed & achieve self-sufficiency; & number referrals for supportive services.
