Economic Security Corporation of Southwest Area (ESC) is providing permanent supportive (PH) housing for chronic homeless persons with disabilities (referred to as the CH program) to bridge the gap between their incomes, services and the cost of affordable housing. Customers are provided rental assistance and other supportive services while they work with their case managers to create and execute a "care coordination plan." This program adds to the residential stability portion of their "plan," by satisfying the immediate need for housing. Participants will come from the streets or shelter settings. We contact the shelters weekly looking for potential clients, when there are CH vacancies. Through The Homeless Coalition, ESC has informal agreements in place with these homeless providers to refer potential participants to the CH program and supportive services. By virtue of the CoC system being in place other agencies throughout The Homeless Coalition (Joplin/Jasper/Newton County Homeless Network) knows where to refer mentally ill and other disabled CH people for permanent supportive housing when they are identified through outreach, intake, assessment, referral and follow-up. The Chronic Homeless Program allows participants to choose their type of housing and in an area where they would want to live. Housing units are selected from the current rental housing market in the area. The units maybe apartments, duplexes or single-family dwelling dependent upon the client's choice and need. Clients are not required to live in specific units or specific neighborhoods. However, they will be assisted in locating neighborhoods that are safe and drug free. This is especially important for those in recovery from substance abuse. Every effort is made to ensure that the location of housing units identified for the project will be close to public transportation and to other amenities such as mental health services, substance abuse treatment services, employment, shopping, recreation, church and other supports the client may need. Services may be within walking distance, accessible by public transportation or provided on-site. All units will be inspected to assure that they meet HUD housing habitability standards. If a program participant needs a unit that is accessible, either for physical or adaptive equipment then they will be assisted in identifying units that will best meet their needs. The amount of rental assistance available is based on the customer paying 30% of their adjusted gross income toward rent and ESC pays the rental gap up to the Joplin MSA Fair Market Rent allowable for federal regulations. The length of assistance is based again on the customer reaching \$0 rental assistance, voluntarily leaving or violation of policy that could cause an involuntary End of Participation. We follow HUD's Part 5 for Income Determination, duration of assistance and amount of rental assistance provided.



The Ozark Center is a partner agency with the Economic Security Corporation of Southwest Area, a community action agency and The Homeless Coalition in their effort to eliminate homelessness in Southwest Missouri. The Ozark Center provides critical supportive services for three of ESC's Department of Housing and Urban Development's renewal projects: Permanent Housing for Persons with a Disability renewal, Chronic Homeless renewal and Shelter Plus Care renewal.

The Ozark Center has been working with Economic Security Corporation for over 14 years to provide case management, mental health and life skills services to homeless clients that need supports to ensure their viability for long term permanent housing. ESC is the permanent housing partner. Ozark Center will be providing in-kind match for all three permanent supportive housing projects mentioned.

The Permanent Housing for Persons with a Disability program renewal, also referred to as Rental Assistance Program or RAP has a program year running from May 1, 2020 to April 30, 2021. During this program year Ozark Center will provide an in-kind match with an estimated value of \$47,011. Services will include \$2,225 for alcohol and drug abuse treatment, \$25,653 in mental health services, \$18,603 in other health services and \$530 in transportation services. These are in-kind donations which includes wrap around case management services for supportive housing and other supportive services, while ESC will offer the permanent housing component.

The Shelter Plus Care program renewal, has a program year running from June 1, 2020 to May 31, 2021. During this program year Ozark Center will provide an in-kind match with an estimated value of \$102,528. Services will include \$1,463 in case management services, \$43,257 in mental health services, \$57,058 in other health services and \$750 in transportation services. These are in-kind donations which includes wrap around case management services for supportive housing and other supportive services, while ESC will offer the permanent housing component.
