## 2B. Project Description

## 1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

The Joplin/Jasper/Newton County Continuum of Care (CoC) continues to coordinate services for people experiencing homelessness. Our service area is small compared to many continuums which create some unique challenges in meeting all the required standards by Housing and Urban Development. Our CoC manages all of the required work with a relatively small volunteer board. We have two paid employees. One is a housing case manager and the other is totally dedicated to Housing Connect, our Continuum of Care's Coordinated Entry. Funds are leveraged from The City of Joplin, Missouri Housing Development Commission, and Community Services Block Grant to pay for these positions. This planning grant will enable the CoC to expand its organizational capacity by providing for some staffing. The funds enable the CoC to successfully address the responsibilities outlined in 24 CFR 578.7 (responsibilities of the Continuum of Care). Our CoC will be more successful in preventing and ending homelessness by providing additional resources to be used for planning, process development, compliance and monitoring. The primary activities to be undertaken with these funds are related to the following: Lead the collaborative process for preparing and submitting the CoC application, 2. Updating and reporting on the CoC Strategic Action plan, and 3. analysis of data in relations to local needs.

Work on the CoC application takes place year round in order to meet all the standards set forth by Housing and Urban Development. Having this planning grant would offset some of the staffing costs associated with putting together the grant. The next item we are purposing to work on is our strategic plan. The two areas of focus will be updating and reporting on achievements. A committee will be assembled to review existing goals and to help set new ones. The last area that will be analysis of our data.

## 2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Upon execution of the planning grant, Economic Security Corporation would work with the CoC to define a plan and assemble committees to perform the work specified in the application. A work plan detailing desired outcomes would be developed. Work on the CoC Application Activities will begin in January with the Point In Time count. Other work will run throughout the entire year. Work on the Strategic plan will begin in January as well and completion will take place by March. The last area, data analysis will begin in May and should take several months to complete.

The following methods will be used to ensure timely and effective completion of work: a committee will be select to work on each of the three activities outlined in the grant. The committees will report back monthly to the Homeless Coalition on progress of work, and committee will follow outlined work plans, that include dates, activities and deliverables. The Collaborative Applicant will participate in

all committees, oversee the entire process and ensure all work takes place.

## 3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

All ESG and COC funded agencies are members of The Homeless Coalition and work within the Jasper and Newton County CoC. Our CoC will be better prepared to evaluate outcomes by completing all items outlined in our scope of work. Having a strong and comprehensive strategic plan will enable us to focus on community and agency goals that will move the needle on ending homelessness. Improving our CoC application, activities and processes will ensure that our community submits the best possible application that focuses on strategies that work to end homelessness. Our current Emergency Solutions Grant Policy and Procedure outlines planning, gaps analysis, Coordinated Entry and monitoring. Our current monitoring plan outlines our process for monitoring both ESG and COC funded projects. It defines the monitoring tool, monitoring team, process, corrective action plan, and file storage. Having robust goals, a strong CoC application and clear policies will only improve our work locally and bring us closer to ending homelessness in our community.
