ESC's Rapid Rehousing project targets chronically homeless individuals and homeless families with children. The goal will be to utilize a housing first approach to house participants as quickly as possible and then offer case management services to stabilize each participant by assisting with employment goals or increasing employment income or to help secure other income sources for participants to successfully maintain permanent housing and not return to homelessness. All homeless individuals and families who present for assistance go through our CoC's coordinated entry process. During this process they are entered into the HMIS (Homeless Management Information System) and placed on a list that is prioritized based on a vulnerability index score. The coordinated entry worker sends out the prioritization list to all area housing providers weekly. Housing providers then make contact with participants who are eligible for their programs when openings are available and work toward permanently housing them. Families and individuals that can be served by ESC's Rapid Rehousing program will see a worker who will complete an Intake Assessment and Referral (IAR) to collect basic information in a variety of areas including housing, food, utilities, employment, etc., which assists with giving referrals for needed programs. The coordinated entry and IAR processes help determine the type of housing that best fits a family's needs. Each participant that can be served by ESC RRH program will be assigned a case manager to work with them step by step in securing housing and other needed services available in the community.
